TRANSPORT, HIGHWAYS, FOOTWAYS & LIGHTING

NCC Notification – To prohibit waiting at any time at the following locations:

- Pine Close (both sides) from its junction with Warsop Lane for a distance of 9 metres
- Warsop Lane (east side) 46 metres south of the entrance to the Health Centre in a north easterly direction to a point 22 metres north of that entrance
- Warsop Lane (west side) 11 metres south of Pine Close in a north easterly direction to a point 60 metres east of Pine Close

The aim of the scheme is to improve visibility due to vehicles parking on the hill outside the health centre.
